Except for sales where livestock are to be delivered at a later date, accounts must be paid at the time of purchase and persons subject to the Packers & Stockyards Act must pay by no later than the close of the next business day following the day of purchase (7 USC 228b). Sales are on a cash basis. In transactions where livestock are to be delivered at a later date, payment shall be in accordance with the contract. If purchases are not paid as specified, the unpaid balance of my purchase will bear interest at Fifteen percent (15.0 %) per annum (or highest rate allowed by law, whichever is lower) until paid in full. If the Market takes legal action to collect my account and prevails, the Market shall be entitled to reasonable attorney's fees and court costs.

This authorization shall remain in effect until I notify the Market in writing that it has been cancelled. A copy of this authorization shall be as valid as the original.
